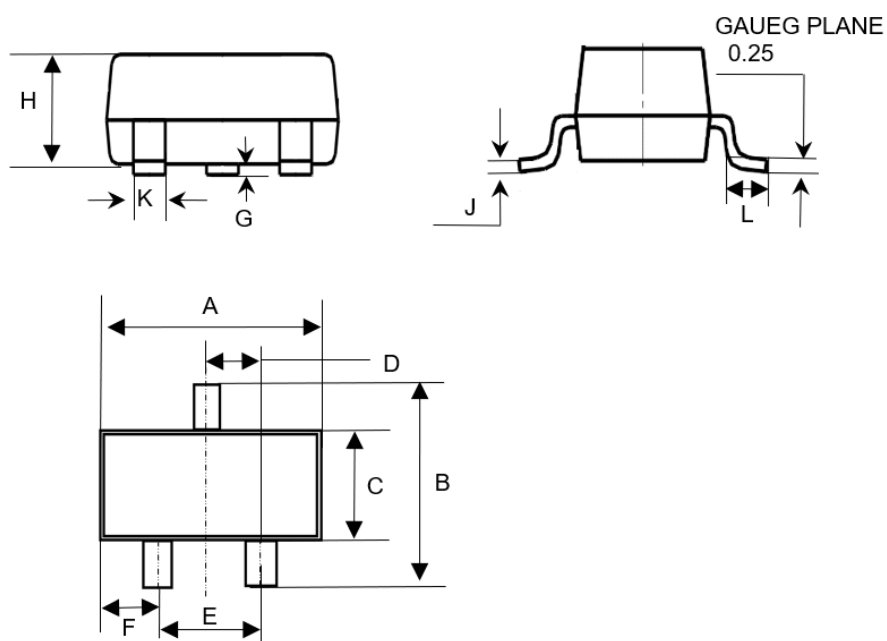

RATING AND CHARACTERISTICS CURVES



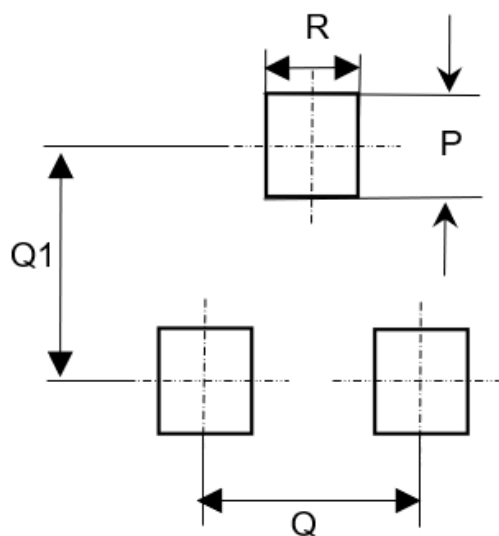
